RULES, REGULATIONS, and GENERAL INFORMATION

1	$\Box \cap$	IRS:

- Show Hours: Friday, September 29, 2023, from 8:00 am to 4:00 pm.
- Setup Hours: Friday, September 29, 2023, from 06:30 am to 8:00 am.
- Set up must be completed by 08:00 am on Friday, September 29, 2023
- All exhibits must be removed by 4:00 pm on Friday, September 29, 2023
- 2. The exhibitor assumes the entire responsibility and liability for losses, damages, and claims on injury, or damage to the exhibitors' displays and equipment or any property brought onto the premises of the White's of Westport, and shall indemnify and hold harmless the Greater Fall River EMS Coordinating Committee, White's of Westport Hospitality Center and their agents, servants, and employees from any such losses, damages, and claims.
- 3. No part of any exhibit, or any signs relating thereto, shall be pasted, nailed, or otherwise attached to walls, doors, etc., in any way as to deface same; damage arising by failure to observe these rules shall be paid by the exhibitor.
- 4. All exhibits shall conform to the size of their space and must not be of such character or arrangement as to obstruct the view or interfere with the exhibits of others. Nothing shall be displayed at a height greater than 10 feet.
- 5. Only three parties will be admitted per exhibitor. All others will be subject to a standard admittance fee.
- 6. All spaces will be issued on a first come, first assigned basis. Every attempt will be made to honor the exhibitor's requests, but the GFREMSCC decision will be final. The GFREMSCC reserves the right to withdraw its acceptance of this application/contract if it determines the Exhibitor's product/service is not eligible to be displayed.
- 7. Unethical conduct or infraction of the rules, on the part of an exhibitor or the exhibitor's representative, or both will subject the exhibitor or the exhibitor's representatives to dismissal from the exhibit hall, in which event it is agreed that no refund shall be made to the exhibitor; and further, that no demand for redress of any kind, will be made by the exhibitor or the exhibitor's representatives.
- 8. Loud speakers, radios, television sets, or the operation of any machinery, flashing lights, or other equipment which is deemed by the Greater Fall River / New Bedford EMS Committee to be annoying to neighboring exhibitors will not be permitted.
